



Overview of changes

This document contains three tables, which precisely show what the approval of the Proposed Rules of Procedure will do to the current Rules of Procedure. This overview shows what articles are changed, added or removed. In addition, it categorizes 4 different types of change. They represent 4 different reasons to change or add the pertained article. You can see those explained below.

1. Content change: The Statutes Focus Group and Board of Extra Muros believe that something should be changed or added content wise. It adds or changes something substantive.
2. Clarification: Changing or adding this article clarifies the original meaning or function it had.
3. Rephrasing: There is merely a language error. This could mean that the English is linguistically incorrect, or that it was incorrectly translated from the Dutch original.
4. Legal correction: This addition or change resolves a legal contradiction or deficiency. It could also mean that the legal reference was incorrect or non-existent.
